Rubber:

The styrene Block Copolymers used (SEBS, SEEPS) are compliant with FDA, Title 21CFR 177. 1810 (b)(3) and FDA FCN No. 63, respectively. The Styrene Block Copolymers, the polypropylene resin and polyphenylene oxide (PPO) used meet the relevant requirements of Framework Regulation 1935/2004/EC, so far applicable for 2 plastic raw materials, used for articles or components of articles intended to come into contact with food.
